ORDINANCE NO. 77-01

AN ORDINANCE OF THE ISLA VISTA RECREATION AND PARK DISTRICT ADOPTING RULES AND REGULATIONS REGARDING VEHICLES AND PARKING ON DISTRICT PROPERTY

(As amended February 13, 2014)

WHEREAS: It is necessary for the proper administration and protection of Isla Vista Recreation & Park District (IVRPD) owned property, improvements and facilities that certain rules and regulations regarding vehicles and parking be enacted;

Therefore, it is ordained by the IVRPD Board of Directors as follows:

- 1. No person shall park any automobile or other vehicle on any property under management of, or belonging to IVRPD except in areas specifically designated and conspicuously marked as parking areas.
- 2. It shall be unlawful for any person to park a vehicle in such a manner as to prevent another vehicle which has been properly parked from backing out, or in such a manner as to prevent a party desiring to park in a designated parking space from driving into said space.
- 3. No automobile or other vehicle shall be driven upon any IVRPD property other than in designated parking areas except as the General Manager may from time to time authorize.
- 4. Restricted parking areas such as "2 Hour Parking" and "Permit Parking Only" zones shall be strictly enforced by ticketing or towing.
- 5. Any violation of this Ordinance is an infraction and carries a fine of one hundred dollars (\$100.00) or the maximum allowed by law at the time of the violation. Repeat offenders, cars blocking right-of-ways, or violations that pose a safety hazard will be subject to having their cars towed at the owner's expense. The IVRPD Park Ranger or designated staff members, any peace officer including but not limited to members of the Isla Vista Foot Patrol, Santa Barbara County Sheriff's Department, California Highway Patrol and University of California Campus Police, or any representative of the Santa Barbara County Fire Department shall have the authority to enforce this Ordinance. Furthermore, at the direction of the General Manager, IVRPD staff shall have the authority to deny use of IVRPD parks, facilities and programs to individuals and groups who violate this ordinance.
- 6. This ordinance is adopted pursuant to Section 5782.221 of the Public Resources Code.

On motion by Director Bessmer, seconded by Director Maghsoodloo, the foregoing amended Ordinance No. 77-01 was passed and adopted by the Board of Directors of the Isla Vista Recreation and Park District at a regular meeting on the 13th day of February, 2014 to be effective 30 days after passage by the following roll call vote:
